Ghana has the most structured gaming industry in W/A with the regulator – Gaming Commission of Ghana introducing compliance metrics with strict enforcement.

However, lottery is regulated by National Lottery Authority.

Nigeria has the most attractive gambling industry with:

Favorable Regulations High Gambling Population



Ivory Coast (LONACI), Senegal (LONASE), Cameroon (MITAD) and Togo (LONATO) operate a monopolized gaming industry (strongly state controlled market) where an operator is required to execute a separate agreement to operate lottery or sports betting within the jurisdiction.



The Republic of Sierra Leone and Gambia gaming industry is regulated by the Tourist Board of their respective jurisdiction, while Gambling in Liberia is regulated by the National Lottery Authority.


